Personal data that Finch processes

Finch processes your personal data because you use Finch' services and / or because you provide these to Finch yourself.

Below you will find an overview of the personal data that Finch processes:

- First and last name;
- Address data:
- Telephone number;
- E-mail address;
- Bank account number.

Special and / or sensitive personal data that Finch processes

Finch' website and/or service does not intend to collect data about website visitors under the age of 16, unless they have permission from their parents or guardian. However, Finch cannot check whether a visitor is older than 16. Finch therefore advises parents to be involved in the online activities of their children, to prevent data about children being collected without parental consent. For what purpose and on what basis Finch processes personal data

Finch processes your personal data for the following purposes:

- Handling your payment;
- Sending a newsletter and / or advertising brochure;
- Being able to call or e-mail you if this is necessary to be able to perform it's services;
- Inform you about changes to Finch' services and products;
- To deliver goods and services to you;
- If data needs to be processed for legally obligations, such as for tax return.

Automated decision making

Finch takes no decisions based on automated processing on issues that may have (significant) consequences for individuals. This is about decisions made by computer programs or systems, without a human being.

How long Finch keeps personal data

Finch does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. For all the categories of personal data, Finch uses the legal retention period of seven years.

Sharing personal data with third parties

Finch does not sell your information to third parties and only provides this if this is necessary for the implementation of its agreement with you or to comply with a legal obligation. Finch enters into a processing agreement with companies that process your data on its behalf to ensure the same level of security and confidentiality of your data. Finch remains responsible for these processes.

Cookie statement

Finch makes use of cookies on its website. A cookie is a simple small file that is sent along with pages from this website and is stored by your browser on your computer's hard drive. The information stored therein can be sent back to our servers on a subsequent visit.

Via Finch' website, the American company Google places cookies as part of the "Analytics" service. Finch uses this service to keep track of and get reports on how visitors use the website. Google may provide this information to third parties if Google is legally required to do so, or insofar as third parties process the information on Google's behalf. Finch has no influence in this. Finch allowed Google to use the analytics information obtained for other Google services.

The information that Google collects is made anonymous as much as possible. Your IP address is explicitly not given. The information is transferred to and stored by Google on servers in the United States. Google adheres to the Privacy Shield principles and is affiliated with the Privacy Shield program of the US Department of Commerce. This means that there is an appropriate level of protection for the processing of any personal data.

You have the right to request access to and correction or deletion of your data. In such case, please contact info@finch-strategy.com. To prevent abuse, Finch might ask you to identify yourself adequately. When it comes to access to personal data linked to a cookie, you must send a copy of the cookie in question. You can find this in the settings of your browser.

View, modify or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent for data processing or to object to the processing of your personal data by Finch and you have the right to data transferability. This means that you can submit a request to Finch to send the personal data that Finch holds about you in a computer file to you or another organization mentioned by you.

You can send a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to info@finch-strategy.com.

To ensure that the request for inspection has been made by you, Finch requests that you send a copy of your proof of identity with the request. Make in this copy your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen service number (BSN) black. This is to protect your privacy. Finch will respond to your request as quickly as possible, but within four weeks.
